BEING A BYLAW OF THE CITY OF DAUPHIN TO CHANGE NAME DESCRIPTIONS OF DESIGNATED CITY OFFICIALS PERFORMING CERTAIN FUNCTIONS

WHEREAS bylaws of the City of Dauphin (and the former Town of Dauphin) designate certain City officials to perform certain functions;

AND WHEREAS the description of these positions has changed from time to time;

NOW THEREFORE the Council of the City of Dauphin, in a meeting duly assembled, enacts as follows:


- (1) Whenever and wherever in any bylaw, resolution, or regulation of the Town or City of Dauphin past, present, or future, the words Secretary-Treasurer, Chief Executive Officer, City Administrator, Chief Administrative Officer, or City Manager appear, they shall be interchangeable and mean one and the same officer, which office is presently described as **City Manager**.
 - (2) Whenever and wherever in any bylaw, resolution, or regulation of the Town or City of Dauphin, past, present, or future, the words Assistant Secretary-Treasurer, Assistant Town Administrator, Assistant City Administrator, City Clerk, Assistant Administrator, Assistant Administrative Officer, Assistant Chief Administrative Officer, or Deputy City Manager appear, they shall be interchangeable and mean one and the same officer, which office is presently described as **Deputy City Manager**.
 - (3) Whenever and wherever in any bylaw, resolution, or regulation of the Town or City of Dauphin, past, present, or future, the words Town Engineer, City Engineer, Manager of Operations, Operations Officer, Director of Operations, or Director of Public Works and Operations appear, they shall be interchangeable and mean one and the same officer, which office is presently described as **Director of Public Works and Operations**.
 - (4) Whenever and wherever in any bylaw, resolution, or regulation of the Town or City of Dauphin, past, present, or future, the words Office Accountant, City Office Accountant, City Accountant, or Director of Finance appear, they shall be interchangeable and mean one and the same officer, which office is presently described as **Director of Finance**.

- (5) Whenever and wherever in any bylaw, resolution, or regulation of the Town or City of Dauphin, past, present, or future, the words Community Economic Development Manager, Dauphin Economic Development Manager, Dauphin Economic Development Officer, or Economic Development Officer shall appear, they shall be interchangeable and mean one and the same officer, which office is presently described as **Economic Development Manager**.
- (6) That Bylaw 03/2007 is hereby repealed.
