



**CITY OF DAUPHIN**

**BY-LAW NUMBER 13/99**

**BEING A BY-LAW OF THE CITY OF DAUPHIN  
TO REGULATE THE USE OF PUBLIC PROPERTY AND PARKS  
WITHIN THE CITY OF DAUPHIN.**

**WHEREAS**, Section 232(1)(b) states:

**A Council may pass by-laws for municipal purposes respecting the following matters:**

**People, activities and things in, on or near a public place or a place open to the public, including parks, municipal roads, recreation centres, restaurants, facilities, retail stores, malls, and private clubs and facilities that are exempt from taxation.**

**AND WHEREAS**, Council of the City of Dauphin deems it desirable to regulate the hours of use of City owned or leased property and parks;

**NOW THEREFORE**, the Council of the City of Dauphin hereby enacts as follows:

1. That the hours of use of all City owned or leased property and parks within the City of Dauphin as listed below shall be between the hours of 7:01 AM to 11:00 PM daily:
  - Vermillion Park - 220 – 2<sup>nd</sup> Avenue NW – Des N, Plan 243
  - Happyface Park – 202/206 5<sup>th</sup> Avenue SW – Lots 7/8, Block 40, Plan 336
  - Gartmore Park – 601/605 Main Street South – Lots 11/12, Block 47, Plan 336
  - Meadowlark Park – 1804 Mountain Road – Parcel A, Plan 2166
  - Pioneer Park – 176 Pioneer Avenue
  - Kirby Avenue Playground – Lots 1 / 2, Block 8, Plan 357
  - Railway Avenue Playground – 205 & 209 Railway Avenue, Lots 4/5, Block 3, Plan 420
  - Kerr Avenue Playground – Public Reserve – Kerr Avenue East
  - Davidson Avenue Playground – Public Reserve - Davidson Avenue East
  - Lilly Avenue Playground
  - Park Crescent Playground
  - CN Park
  - CN Station & Grounds

2. No person shall be allowed to be present within the above noted City owned or leased property and parks within the City of Dauphin between the hours of 11:01 PM to 6:59 AM excepting the following:
  - Persons camping in the Vermilion Park.
3. The City of Dauphin, upon passing of the bylaw shall ensure that a sign stating the hours of use shall be posted at each property.
4. A person who contravenes this by-law is guilty of an offence and, is liable upon summary conviction to a fine of not more than \$ 500 or to imprisonment for a term of not more than three (3) months or both.
