BY-LAW NO. 06/2024

Being a By-Law of the <u>City of Dauphin</u> to amend its By-Law No. <u>07/2023</u>

Expenditure and Borrowing of Money for the South-End Land Drainage System as a Local Improvement

WHEREAS, the <u>City of Dauphin</u>, by its By-Law No. <u>07/2023</u>, which was authorized by Municipal Board Order No. E-23-073. is inter alia, authorized to issue borrowing in the amount of \$8,150,000;

AND WHEREAS, no borrowing as authorized by said By-Law No. <u>07/2023</u> has been issued or sold;

AND WHEREAS, the City of Dauphin has made arrangements to borrow *Series "A"* from the *Minister of Finance of the Province of Manitoba* in the amount of \$5,500,000, being the costs of works completed under the authority of By-Law No. <u>07/2023</u>, such borrowing to be dated September 30, 2024, to bear interest at the rate of 5.225% per annum, payable annually during their currency, and to mature on December 1st in each of the years 2025 to 2044;

AND WHEREAS, it is deemed expedient to amend said By-Law No. 07/2023 to provide for the issuance of the aforesaid borrowing;

NOW THEREFORE, the Council of the <u>City of Dauphin</u>, in council duly assembled, hereby enacts as follows:

- 1. **THAT** By-Law No. <u>07/2023</u> of the <u>City of Dauphin</u> **BE AND THE SAME IS HEREBY AMENDED** to provide that <u>Series</u> "A" borrowing in the amount of \$5,500,000 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 30th day of September, 2024, to bear interest at the rate of 5.225% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 1st day of December in each of the years 2025 to 2044, both inclusive.
- 2. **THAT** upon further works being completed under authority of By-Law No. 07/2023 the *City of Dauphin* shall, from time to time enact such additional by-laws as may be required for the issuance of borrowing to secure the costs incurred.
